Terms and Conditions:

Orders and acceptance

- The delegate is deemed to accept these terms and conditions (the "Terms") upon registering for the Active Fusion Conference (the "Event") and is responsible for ensuring the accuracy of all details submitted.
- These Terms govern the booking for the Event and attendance at the Event. The Event website incorporates these Terms, and they constitute a legally binding contract at the point of booking.
- The closing date for bookings is 17:00 on Friday 22nd April 2022, or earlier should capacity be reached.
- Confirmation of the booking will be sent via an automated email at the time of registration.
- Places are offered on a first come, first served basis; the only delegates who have a guaranteed place at the Event are those who have received the email acknowledgement.

Fees

- The prices for the Active Fusion Conference are per delegate ("delegate fee") and include all fees, materials and refreshments.
- We will endeavour to accommodate all dietary requirements providing that the delegate provides this information within 14 days of the Event, however we are unable to guarantee this.
- All prices include VAT.
- Payment in full must be received and cleared by Active Fusion on booking to guarantee your place.
- We accept payment by bank transfer.

Cancellations

- Active Fusion reserves the right to cancel or postpone the Event without notice. In the case of the Event being postponed, whether this is at the charities discretion or due to imposed national restrictions, delegate registrations will automatically be transferred to a revised date. For any delegates unable to attend this revised date, a refund will be issued. This request for a refund must be communicated in writing to info@activefusion.org.uk. Any refund will be limited to the amount already paid by the delegate to secure their place at the Event.
- In the event of cancellation by a delegate, cancellation fees will be due as follows. A full refund will be made for cancellations prior to 1st April 2022. 75% of the delegate fee will be charged for cancellations received after this date.

Force majeure

- Active Fusion will not be liable for any failure or delay in the delivery of the Event which is caused by circumstances beyond its reasonable control.
